DESCRIPTION

• lightweight safety ankle shoe in a modern, sporty design • the upper is made of breathable textile • the oil-resistant non-slip outsole is made of double-density polyurethane and ensures maximum safety at every step • in addition, the shoes are equipped with a comfortable inner insole, which guarantees comfort while walking • the absorption of energy in the heel area absorbs shocks and reduces the feeling of fatigue in the feet • thanks to a light, and modern toe cap made of fiberglass, the footwear meets the requirements of the EN ISO 20345: 2011 standard • the feet are protected against compression with a force of up to 15 kN or the fall of a load of up to 20 kg from a height of 1 m • the feet are also protected from below, thanks to the composite antipuncture midsole • the shoes do not contain metal parts and are equipped with the ESD function • therefore, it is an ideal model for indoor spaces and sensitive environments, where it is necessary to prevent sparks from electrostatic discharge or for rooms equipped with a safety frame • thanks to the modern materials used in production of this model, the total weight of the shoes does not exceed 570 g (half-pair size 42) • minimalist design and modern colors will go great with most of Cerva's workwear collection
